Today's LINAK systems offer consistent speeds, enhanced stability (with or without a cross support), forwards/backwards compatibility and many optional upgrades. Many of which, including PVC-free and ZERO[™], have been rolled out as standard to give our customers more value without additional cost.

New generation of control boxes

One of our newest initiatives has been the redesign of our control box technology. We switched from large, heavy transformers to a lightweight SMPS (Switch Mode Power Supply) technology. This drastic reduction in weight (from approx. 1.6kg to 400g) reduces shipping and handling costs. Installation times are also less because these boxes can be mounted with only one screw and are much more compact.

Focus on design

We introduced invisible gliding pads on columns and small steps between the profiles for better aesthetics.

Focus on wellness

Our new software, Desk Control[™], encourages users to stand more during the day to improve their health and productivity.

PIEZO[™]

This hardware based anti-collision technology is more sensitive and works faster than a typical software solution. The sensor detects obstructions, then halts and reverses to avoid collision.

ZERO[™] technology

All DESKLINE control boxes are designed to have an extreme low standby power consumption which means less emissions and less power used.

With the ZEROTM technology it is possible to reduce the typical standby consumption of 1-2 W to just 0.1W. This is less than a phone charger (not charging: 0.26W)*.

PVC-free systems

For health reasons and for the sake of the environment LINAK offers entire systems free of polyvinyl chloride.

RoHS2 compliant - banning of hazardous substances

All LINAK products are RoHS2 compliant. The RoHS directive (Reduction of Hazardous Substances in Electrical and Electronic Equipment) requires the following substances are banned: Lead, Hexavalent Chromium (Chrome VI), Mercury, Cadmium, Polybrominated Biphenyles (PBB), Polybrominated Diphenyl Ethers (PBDE).

Conflict minerals

LINAK has established a team to examine the impact of the Dodd-Frank Act. We will engage in dialogue with stakeholders to determine how LINAK can help our customers live up to their compliance obligation. We will investigate processes and solutions to enable disclosure of the origin of conflict minerals and we will be highly supportive of internationally recognized database systems providing relevant disclosure of origin.
