

## **CORROSION PROBLEM EXPLAINED**

### **CORROSION AND BUILDING REGULATIONS**

Mandatory documents in construction do not address corrosion properly and provide Owners with a minimalist approach to corrosion control. These include;

### National Construction Code (NCC) 2016: Volume 2: Table 3.4.4.2



More than 100m from salt water recommends single pack paints.



Less than 100m from salt water recommends an outdated coating system.



Nominates Hot Dip Galvanizing (HDG) as a suitable alternative however greater thickness would be required to achieve 15 year durability within 100m from salt water.



These are inferior modes of protection.

Australian Building Codes Board (ABCB) Handbook: Durability in Buildings **Including Plumbing Installations: 2015** 



The Handbook nominates a 15 year design life for components however Section 3.4.2 relegates corrosion protection to a maintenance issue and not a component

Australian Standard 4100:(R2016) - Steel Structures



Does not provide a specific reference to corrosion control or coatings

### **INSURANCES AND GUARANTEES TO PROTECT YOU, THINK AGAIN!**

Reactively dealing with corrosion is a costly exercise where disassembly of building components is likely required for remedial works. The repair methods required are often unsuitable in an occupied building and therefore lesser methods of protection are accepted in lieu of the preferred requirement.



 Resultant damage losses such as water ingress can form part of a claim under home building and contents insurance if not unreasonable for the home owner to be unaware of the rust situation however insurers generally exclude corrosion as they see this as a maintenance issue.



- Implied warranties automatically apply to all domestic building work, regardless of the cost or whether or not there is a written contract.
- These warranties transfer to a new owner for up to 10 years from completion of the work.
- This right transfers to a new owner if the property is sold within this time.



- The insurance is 6 years for Structural defects and 2 years for Non-Structural defects.
- Corrosion protection is likely considered non-structural thus only offering 2 years protection.




